## 8. Discussion and Possible Approval of Hunting Economics Virtual Report opportunity: Tony

- a. Bobby Jones with NDOW: BJ presented to Lander Co. CD on a hunting economics report he partnered with UNR Cooperative Extension that outlines how hunting impacts rural economies on a county-by-county basis. He also presented on survey results from a statewide survey NDOW distributed geared towards helping us better understand public values as it relates to time spent outdoors, and personal health.

- 9. Discussion and Possible Approval of Spring Protection/Development project through FWS: Tony
  - a. Cheryl Mandich email comments: The project for consideration is detailed below. It will depend on how much funding remains after the budget has been created for the two projects the VCD has already approved.
  - b. The ranch falls within the boundaries of the Vya Conservation District. Spring boxes will be constructed at two springs which will be protected by the use of exclosure fencing. Two water troughs will be added along with a water storage tank. The overflow on both spring boxes will be used to fill the water troughs. Floats will be placed on the troughs so when they hit overflow, the water will be directed to a pipe which will transport the water down towards additional watering sources. This will enhance the water quantity and quality that is available to livestock and wildlife. The additional water locations will also assist in distributing livestock grazing.
